

विषय:- प्रशिक्षु अधिनियम (अप्रेंटिस एक्ट) 1961(संशोधन 1973, 2014 एवं 2019) के अंतर्गत वर्ष 2023-24 के लिए ग्रेजुएट अप्रेंटिस एवम टेक्नीशियन अप्रेंटिस की प्रैक्टिकल ट्रेनिंग के लिए नियुक्ति पत्र।

उपयुक्त सन्दर्भ के आलोक में, मेडिकली उपयुक्त पाए जाने पर अप्रेंटिस अधिनियम 1961 (संशोधन 1973, 2014 एवं 2019) में निर्धारित शर्तों के अनुसार 01 वर्ष की अवधि के लिए ग्रेजुएट अप्रेंटिस/इंजिनियरिंग स्टडीज/मेकेनिकल/इलेक्ट्रीकल/सिविल, ग्रेजुएट अप्रेंटिस/जनरल स्टडीज/बीएससी/बी काम/बीसीए, टेक्नीशियन अप्रेंटिस/मेकेनिकल/इलेक्ट्रीकल/सिविल के रूप में प्रैक्टिकल ट्रेनिंग प्राप्त करने हेतु आपको नियुक्ति पत्र प्रदान किया जाता है।

02 प्रशिक्षुता के लिए नियुक्ति (इनगैजमेंट), निम्नलिखित शर्तों के अधीन रहेगी:

(i) आचरण एवं अनुशासन के मामले में प्रशिक्षु को, आयुध निर्माणी चान्दा के नियमों विनियमों को मानना होगा एवं आयुध निर्माणी चान्दा के नियोजता एवं परिषदों के विधिसम्मत आदेशों का पालन करना होगा।

(ii) ग्रेजुएट अप्रेंटिस टेक्नीशियन अप्रेंटिस, एक प्रशिक्षु के रूप में व्यवहार करेंगे, न कि एक कामगार (वर्कर) के रूप में। प्रशिक्षण की अवधि समाप्त होने से पहले, वे पोस्ट इस्टीमेटेशनल ट्रेनिंग की शिक्षा लेंगे। प्रशिक्षु अधिनियम (अप्रेंटिस एक्ट) 1961(संशोधन 1973, 2014 एवं 2019) के उपबंधों के अतिरिक्त (या को छोड़कर), श्रम से संबंधित कानून की शर्तें उस पर लागू नहीं होंगी।

(iii) ग्रेजुएट अप्रेंटिस टेक्नीशियन अप्रेंटिस नियमित रूप से शॉप फ्लोर में प्रैक्टिकल ट्रेनिंग लेंगे एवं उससे संबंधित निर्देश, यदि कोई हो तो उसका भी पालन करेंगे।

(iv) बहुत अधिक आवश्यक मामले एवं चिकित्सा अवकाश को छोड़कर, प्रशिक्षु, अनुभाग के उपयुक्त प्राधिकारी को अवकाश हेतु आवेदन प्रस्तुत करेंगे एवं छुट्टी लेने से पहले स्वीकृति प्राप्त करेंगे। प्रशिक्षु को, नियोजता के साथ प्रशिक्षण के अनुबंध पर प्रवेश करना होगा।

(v) आपको, ज्याइनिंग की तिथि से 01 वर्ष की अवधि के लिए, नीचे दिए अनुसार, मासिक वृत्तिका (मंथली स्टाइफंड) प्रदान की जाएगी:



MEMORANDUM

The undersigned hereby offers to Mr. Nayakar Tushar Dnyaneshwar (son of Sh. Dnyaneshwar Nagaji Aautkar a post of Constable (General Duty) in the minimum pay of Rs. 21,000/- (one lakh) in the Pay Matrix (Level-3) in Sashastra Seema Bal. He will also be entitled to draw other allowances, at the rates as applicable to Central Govt. employees, subject to the conditions as laid down in the rules and orders governing the grant of such allowances in the Force from this date.

The terms and conditions of appointment are as follows:-

- 1. On joining the Force, he/she will be governed by the Sashastra Seema Bal Act 2007 & Rules 2008, manuals & other instructions as issued and amended from time to time by the Government.
- 2. The appointment is purely temporary but likely to continue. He/she will be on probation for a period of 02 (Two) years from the date of appointment. The competent authority as prescribed under SSB Rules may for the reasons to be recorded in writing, extend the period of probation for such further period or periods not exceeding two years or may state the period of probation, terminate his services without assigning reasons. He/she permanent appointment to the post, however, will depend upon various factors governing terms of permanent appointment to such post as time and time.
- 3. He/she services on such a temporary Government service shall be liable to termination at any time by a notice in writing given either by him to the appointing authority or by the appointing authority to him. The period of notice shall be one month; provided that the services may be terminated forthwith and on such termination, he/she shall be entitled to claim a sum equivalent to the amount of pay plus allowances for the period of his notice at the same rates at which he/she was drawing them immediately before the termination of his/her services or, as the case may be, for the period by which such notice falls short of one month.
- 4. The competent authority as prescribed under SSB Rules may having regard to the special circumstances of any case, permit he/she to resign from the force before completing the term of the engagement; provided that while granting such permission the competent authority as prescribed may require he/she to refund to the Government such amount as would constitute the cost of training given to he/she or three months pay and allowances, whichever is higher. Provided further that he/she on tendering resignation, for accepting a job under the Central or State Government and local bodies, after having been granted notice clearance for the same or who has completed ten years of service shall not be required to refund the sum as provided here in above.
- 5. On appointment he/she shall be liable to serve in any part of India as well as outside India.
- 6. He/she will be governed under the Contributory Pension Scheme for pensionary benefit effective from 01/01/2004.
- 7. He/she will have to qualify "Basic Rural Training Course" being conducted by Sashastra Seema Bal within a period of two years from the date of appointment. Not more than two chances will be given to qualify Basic Rural Training Course failing which he/she services shall be liable to be terminated.
- 8. He/she will have to undergo special training courses, as may be prescribed, from time to time.
- 9. He/she will not be entitled to any Traveling Allowance/Diarness Allowance for joining on he/she first appointment.
- 10. He/she should bring a Certificate from the local administrative authorities like tal. Clerk, Magistrate/Sub-Divisional Magistrate / Tehsildar or any other officer to them at the State/Central Government, regarding he/she character and antecedents (as per format enclosed), which should have not been issued before six months of date of joining.
- 11. The verification of Character and Antecedents would be carried out immediately on joining from the concerned District Administration. In the event of furnishing false or incorrect information at the time of appointment in the service, he/she service is liable to be terminated as per the provisions of SSB Act and Rules. Moreover, if any false or untrue statement mentioned by the candidate in the attention form being found false or incorrect or any adverse finding is reported against him or her, the individual is also liable for disciplinary action under the provisions of SSB Act and Rules.
- 12. He/she has been selected against the vacancy of General category. The appointment is provisional and is subject to verification of Schedule Caste/Other Backward Classes Certificate (if applicable). If the verification reveals that the claim belonging to Scheduled Caste/Scheduled Tribe or OBC, as the case may be, is found false, he/she services are liable to be terminated forthwith, without assigning any further reasons or without prejudice to such further action, as may be taken under the provisions of the SSB Act 2007 / Indian Penal Code for production of false certificate.
- 13. For Other Backward Classes candidate the Community Certificate should invariably be issued by the designated authority only. If on verification it is revealed that he/she claim of belonging to Other Backward Classes and not belonging to Creamy Layer is false, he/she services will be terminated forthwith without assigning any further reasons or without prejudice to such further action as may be taken under the provisions of SSB Act 2007/Indian Penal Code for production of false certificate.
- 14. He/she should bring Verification Roll form (enclosed) obtaining signature with seal on the "Identification Certificate" by any Gazetted Officer mentioned in the certificate at post 4 of Verification Roll.
- 15. Women candidate only: Those women candidates who appear for joining in pursuance to the "Offer of Appointment" and as a result of which is found to be pregnant or (2) twelve weeks standing or over shall be declared "Temporary unfit" and her appointment shall be held in abeyance until the confinement is over. She should be re-examined for a fitness certificate six weeks after the date of confinement, subject to the production of a medical certificate of fitness from a registered medical practitioner. Those women candidates who is found to be pregnant or stand less than (2) twelve weeks standing will be allowed to join but will not undergo BRTC at the time of her joining. She will report back to her unit in case of joint training centre.

The appointment will further be subject to:-

The extension of a declaration about he/she marital status in accordance with the orders in force regarding appointment under Govt. of India that no person, who has more than one spouse living or who having spouse living in any case in which such marriage is void by reason of its taking place during the life time of their spouse, shall be eligible for appointment, engagement, or employment in the Force. Any person subject to the NSR Act, who contracts a marriage during the life time of he/she first spouse shall render he/herself ineligible for retention in service and may be liable for dismissal from service on ground of unsuitability. Provided that the Central Government may, if satisfied that there are special reasons for doing so, exempt any person from the operation of this sub-section. Therefore:-

The effect of having more than one spouse being, the appointment will be subject to his/her being divorced from his/her former spouse for any specific reason he/she is considered by the Government and specific exemption granted therein.

- Before his/her appointment he/she is required to sign the form of appointment as set out in Appendix of SSB Rules 2003 in case he/she has been answer to any such question put to him/her that he/she is liable to punishment under SSB Act 2003.
- Taking of an Oath of Allegiance to the Constitution of India or making a solemn affirmation to that effect in the prescribed form as mentioned in Appendix - I of SSB Rules 2003.

4. At the time of joining the post, he/she is required to furnish the following documents:

- a. Original Certificate of SC/ST/OBC or Anglo - Indian Community of applicant.
- b. Non-Courty Lawyer Certificate in case of OBC candidates. Specimen Proforma is enclosed.
- c. Marital Certificate issued by the revenue authority and follow the form of Schedule.
- d. Original educational Certificate.
- e. Certificate relating to Date of Birth, age relaxation, if any.
- f. Discharge Certificate, if any.
- g. Recent passport size colour photographs (12 Nos).
- h. If any case prosecuted against you in any Court of law, copy of the orders passed by the court and if the case is still pending against you, copy of complete case documents.
- i. If a donor in your personal or company (debiting and receiving) banking, also bring Rs. 4000/- to meet your banking requirement for the account verification (Rs) enclosed, obtaining signature with seal on the "Mandatory Certificate" by any Gazetted Officer as mentioned in paragraph 4 of advertisement.
- j. Certificate from the local administrative authority (the 1st Class Magistrate/Sub-Divisional Magistrate/Territorial or any Officer superior to him/her) in the State/Central Government, regarding his/her character and antecedents (see para format enclosed), which should have not been issued within six months from the date of joining.

5. He/she is required to state, if he/she is serving or is under obligation to serve another Central Govt. Department, a State Government or State Govt. undertaking.

6. He/she is required to submit an undertaking that if any adverse report comes into the notice during the course of verification of his/her Character and Antecedents through local administrative/Police authorities his/her services may be terminated without assigning any reason.

7. If any declaration given or information furnished by him/her is found to be false or if he/she is found to have wilfully suppressed any material information, his/her services shall be liable to be terminated along with such other action as may be deemed fit under SSB Act 2003 & SSB Rules 2003 and the Central Government may deem necessary.

8. **Mr. Ashok Tushar Dnyaneshwar Son of Sh. Dnyaneshwar Nagji Ashok** accepts the offer of appointment by the post in accordance with the above terms and conditions. He should report at **ATC Shamshi, Shamshi, Himachal Pradesh** (joining instructions enclosed) along with the documents on **16/12/2022** without fail. Failing which his/her candidature will be cancelled.

9. On reporting to the **Commandant ATC Shamshi, Shamshi, Himachal Pradesh** on **16/12/2022**, he will join and will be deemed to be accepted by the SSB.

10. He/she is required to be freed from the date of joining.
